### **CHARACTER**

A Letter of Recommendation is required from an independent sponsor (e.g., school representative, church or community leader, etc.) that explains how the applicant's character has played roles in enabling him/her to succeed. Character traits such as integrity, innovation and accountability should be mentioned.

- What character traits did the applicant use to help him/her triumph over the challenge(s)?
- Other pertinent comments from the letter writer.
- Overview: Why do you think the applicant should be awarded the scholarship?
